### EVERY DAY COUNTS LICENSE TERMS AND CONDITIONS

1. **Acceptance of Terms and Conditions.** These License Terms and Conditions (these “Terms”) govern your download and use of the **Every Day Counts Demo Coins & Depositor Money** file specified on the attached Quote or Order (the “the Product”). By accepting a Quote, submitting an Order, or downloading the EDC Product, you agree to be bound by these Terms. If you are ordering or downloading the Every Day Counts Product on behalf of a school, district, or other entity, you represent and warrant that you have the right, power, and authority to bind that school, district, or other entity to these Terms. If you do not agree to these Terms, you may not access, use, or download the Every Day Counts Product on behalf of yourself or any other party. For purposes of this Agreement, “Licensee” refers to you and any employer or other entity on behalf of which you access, download, or use the Every Day Counts Product.

2. **Grant of License.** Gillespie Kanter Group LLC (“GKG”) hereby grants Licensee a limited, non-exclusive, non-transferable license to the Every Day Counts Product for the purpose of downloading, **reproducing (as hard copies only)**, and distributing hard copies of the Every Day Counts Product solely in the quantity specified on the attached Quote or Order Form (the “Licensed Quantity”). For a *K-5 site license*, the Licensed Quantity is for the total classrooms in the purchasing school. **Reproducing or distributing the Every Day Counts DC Product or portions of it in any other format** or in amounts exceeding the Licensed Quantity **is prohibited**.

3. **Ownership.** GKG is the owner of all right, title, and interest in and to the Every Day Counts Product and the EVERY DAY COUNTS trademark. Licensee acquires no right, title, or interest or claim of ownership in the Every Day Counts Product or the EVERY DAY COUNTS trademark, apart from the limited license granted in these Terms. Licensee agrees to notify GKG of any unauthorized use or distribution of the Every Day Counts Product of which Licensee becomes aware.

4. **Audit Right.** Upon reasonable notice, GKG may conduct an audit during normal business hours to confirm Licensee’s compliance with these Terms. Licensee will provide GKG or its designee reasonable access to Licensee’s premises and records to permit GKG or its designee to conduct the audit. If an audit reveals that Licensee’s use of the Every Day Counts Product violates these Terms, Licensee will promptly compensate GKG for any copies of the EDC Product exceeding the Licensed Quantity and will immediately cease any other unauthorized use of the Every Day Counts Product. In such event, Licensee will reimburse GKG for the costs of the audit.

5. **Term.** These Terms will remain in effect for one (1) year after the date of the relevant Quote or Order Form, unless terminated pursuant to this Section. GKG may terminate these Terms and the foregoing license upon written notice to Licensee in the event of Licensee’s breach of these Terms. Upon termination or expiration of these Terms, the license granted in Section 2 above will terminate and Licensee must immediately cease and discontinue all use of the Every Day Counts Product and destroy all copies of, or materials incorporating, the Every Day Counts Product.

6. **Notice.** The address of each party as set forth in GKG’s then-current records will be the appropriate address for notices. All notices will be sent certified or registered mail, with a copy sent by email, and will be deemed received when actually received. Either party may change their notice address by written notice to the other.

7. **Miscellaneous.** The license granted to Licensee is personal and may not be assigned or otherwise transferred without the prior written consent of GKG. The validity, interpretation, and enforcement of these Terms shall be governed by the laws of the state of Oregon (without reference to the principles of conflict of laws thereof). These Terms constitute the entire agreement between the parties related to their subject matter. These Terms may not be amended except in a writing signed by both parties.
